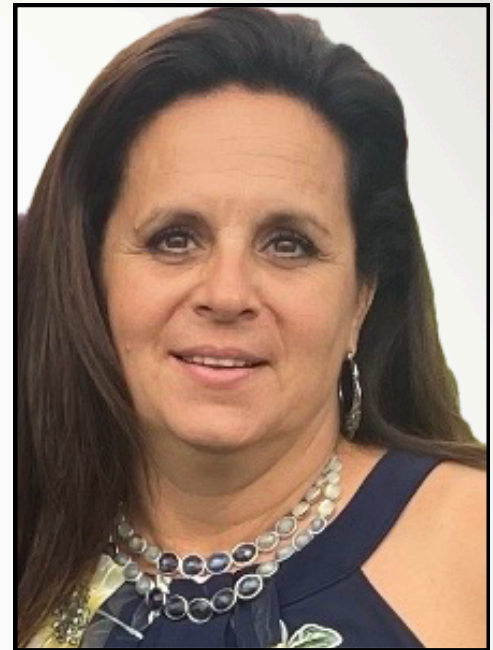
Position on the board: None yet, but looking to help on current committees.

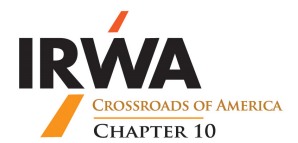

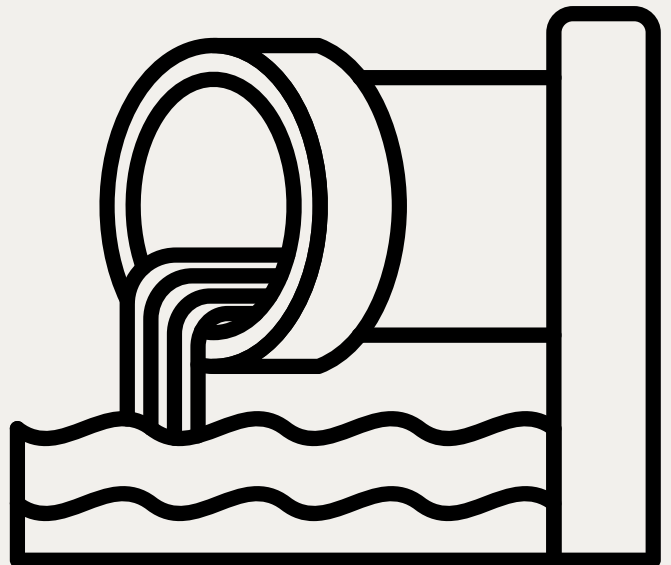
